The salary as provided shall be considered as full compensation for all work required and performed within Teacher's prescribed scope of duties and responsibilities. Teacher's salary for new employees will be based upon estimated years of experience provided by the employee at the time of employment subject to adjustment during the contract period if the years of experience recognized for pay purposes cannot be verified in accordance with board policy and/or procedures.

The Superintendent may terminate the Teacher's employment in accordance with the provisions of state law.

If, during the term of this contract, the Teacher should lose proper certification or otherwise become disqualified to serve in the position listed above for any reason, this contract shall be immediately rendered null and void.
