

SAMPLE BALLOT INSTRUCTIONS FOR VOTING

- 1 Press the box to the right of the candidate of your choice or YES or NO question; a green X will appear to the left of the box X indicating your selection.
- 2 To change a selection, press the box again. The green X will disappear and you may make a new selection.
- 3 Make **ALL** selections, then press the button located in the lower right corner. This electronically records all of your votes.
- 4 Part the curtains and exit the voting booth.

School District No. 2 Proposition	
<p>Shall School District No. 2 of the Parish of Richland, State of Louisiana (the "District") (through the Richland Parish School Board acting as the governing authority thereof), incur debt and issue bonds not exceeding One Million Seven Hundred Fifty Thousand Dollars (\$1,750,000) to run not exceeding twenty (20) years from date thereof, with interest at a rate or rates not exceeding five percent (5%) per annum (the estimated millage rate to be levied in the first year of issue is 10.5 mills), for purposes of acquiring and/or improving lands for building sites and playgrounds; including construction of necessary sidewalks and streets adjacent thereto; purchasing, erecting and/or improving school buildings and other school related facilities within the District and acquiring the necessary equipment and furnishings therefor, title to which shall be in the public, which bonds will be general obligations of the District and will be payable from ad valorem taxes to be levied and collected in the manner provided by Article VI, Section 33 of the Constitution of the State of Louisiana of 1974 and statutory authority supplemental thereto?</p>	<p>YES <input type="checkbox"/></p> <p>NO <input type="checkbox"/></p>
Hospital Service District No. 1-B Proposition	
<p>Shall the Hospital Service District No. 1-B of the Parish of Richland, State of Louisiana (the "District"), be authorized to renew and continue to levy and collect a special tax of ten and ninety-six hundredths (10.96) mills (the "Tax") on the dollar on all property subject to taxation in the District, (an estimated \$1,046,199.18 reasonably expected at this time to be collected from the levy of the Tax for an entire year), for a period of ten (10) years, beginning with the year 2022 to and including the year 2031, for the purposes of constructing, maintaining, improving and operating the hospital facilities of the District, including the purchase of equipment therefor, said Tax to be a renewal of an existing tax which will expire in 2021?</p>	<p>YES <input type="checkbox"/></p> <p>NO <input type="checkbox"/></p>
